Rules for conducting Annual conference of IAS- IASCON 2027 (Zone 3)

1. All the fields are mandatory, incomplete or wrong information will lead to disqualification.
2. Name Organising Chairman and Organising Secretary is must.
3. Please mention IAS Life membership number at designated place.
4. Form should be typed or filled manually and should be legible and all the pages should be signed.
5. Duly completed form's scanned copy should be emailed to IAS Secretary Dr Rajeev Raman on secretary@indianarthroscopy.co.in before 24th February 2026, by 05:00 pm. Last date for withdrawal of bid will be 28th February 2026, by 05:00 pm.
6. As mandated by GBM Lucknow 2023:
 - a. IASCON should be held on IAS GST, PAN & TAN Card.
 - b. IASCON Account should be sub account of IAS Main account.
7. As mandated by Extra-Ordinary GBM & GBM Lucknow 2023 IASCON will be held in zone wise.

Amendments are as follows:

a. Five zones representing various states of India are proposed:

- i. Zone 1: Goa, Gujarat, Maharashtra, Telangana
- ii. Zone 2: Jharkhand, Odisha, West Bengal, North Eastern states of India
- iii. Zone 3: Delhi & NCR, Jammu & Kashmir, Punjab, Haryana, Himachal Pradesh, Chandigarh, Uttarakhand
- iv. Zone 4: Bihar, Chhattisgarh, Madhya Pradesh, Uttar Pradesh, Rajasthan
- v. Zone 5: Karnataka, Kerala, Tamil Nadu, Andhra Pradesh, Puducherry

b. It is proposed to conduct the IASCON zone-wise starting with Zone 1 in 2025. The subsequent rotation would be to Zone 2 and 3 and 4 and 5 and then back to Zone 1.

c. The venue selection would be made with the Elections of the Governing Council Online.

d. Bid winning city will not be given the subsequent IASCON during the next zone rotation cycle.

e. During the zone rotation if there are no bids from that state then the city which has won bid during last rotation cycle may be allowed to bid. (Rule 'd' will not be applicable)

8. As mandated by Extra-ordinary GBM & GBM Bengaluru 2024:
 - a. IAS Secretary and organising Secretary will be the signatories of IASCON account.
 - b. Starting from IASCON 2025 Goa, 10% of total revenue collection barring taxes should be paid to IAS by the IASCON organisers.
 - c. From 2028 IASCON will be awarded to only affiliated state chapters.
 - d. Bid should be submitted through affiliated state chapter along with letter of support, signed by president and secretary of the state chapter.
