Dr.IPS Oberoi, President IAS requested Prof.Arumugam S to present about the recent developments of the IAS Registry.

Dr.Arumugam presented the same & highlighted these points.

The IAS ACL registry app ilog was launched on 12 Sep 2018 and was in use thereafter.

He presented the brief data statistics collected via this app and explained the following salient points,

- 1.Good early reception
- 2.Slowly fading interests, lack of motivation among members
- 3.Inability to understand long term effects of registry among members
- 4.Change of office bearers & lack of continuity in the registry proceedings
- 5.Developers problems: change in management within company, employees etc He presented a fresh proposal for a more secure & standard arthroscopy registry, containing these points.

1. Tie-up with a established, exclusive & experienced registry company (Northgate public services, UK - handling Euro-spine & National joint registry UK)

2. Dedicated long term committee to foresee the development, maintenance & outcome of the registry.
